Our constitution promises not only political but also social democracy. Democracy in any sense cannot be established unless certain minimal rights which are essential for a free and civilized existence are assured to every member of community irrespective of caste, creed, religion, language and over distinction of differently abled and non differently abled persons in the community. During the last two decades there has been a shift of emphasis in policies from a welfare and charity approach to that equalization of rights and opportunities. Our Indian disability law treats disability is a civil rights rather than a health and welfare issue. The law recognizes the primary issue facing the differently abled persons is their exclusion from the main stream activities of the society and hence the emphasis in the law on full integration and participation.

But regret much has been written and spoken about political lethargy and weak executive actions in promoting equal opportunity ecosystem for the persons with disabilities. However amidst poor implementation of Laws and Government schemes for the benefits of the PWDs, judiciary is holding a fort firmly for ensuring that the differently abled persons are duly recognized as the part of the main stream strata of every walk of life. In the new scenario of awareness of the persons with disabilities (PwDs) have learnt to move from an environment of expectation to an environment of rights.

For the prevention and rehabilitation of PwDs organization with the financial assistance of Govt. of India, has been continuing action oriented activities and training programmes, social mobilization, capacity building training programme, vocational training, Self Help Groups (SHGs) for the differently abled women and institutional based Special School for the Spastic (CP & MR) Children. Now organization emphasized for the rehabilitation of the vulnerable segment population of The National Trust disability areas (Autism, C.P, M.R & Multiple disabilities) in the community.

I would also thanks to the Govt. officials, Local NGOs, Odisha vikalanga mancha and Authorities of educational institutes for their corporate action of support system in helping us to accept the challenges that we face us in translating the dreams of PwDs in an expected extent of possible.

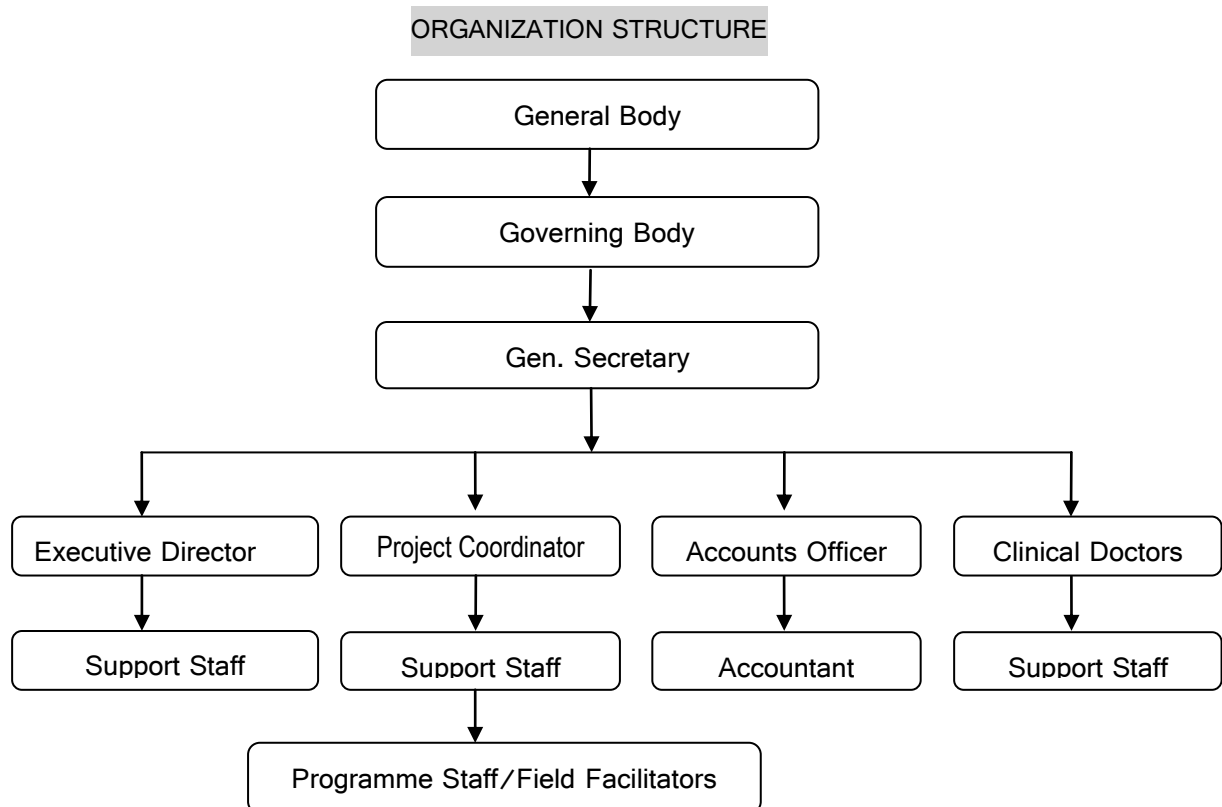

Realizing this very disparity, a team of professional who has not only sensitive but also trained up in implementing developmental programmes, came together on a single platform to undo the injustice meted out to these unfortunate people. The efforts of professionals took a concrete shape in the late research (CRSR) which was registered as a voluntary organization under the relevant Act. To achieve the long term objectives, organization also be registered under various other Acts at status.

VISION STATEMENT

CRSR, the voluntary development organization engaged in socio-development alternatives, aims to promote a society free from exploitation, injustice and to make community self reliant based on model principles of an egalitarian society. Organization rejuvenates the team spirit of marginalized class of people and also the distressed differently abled segment of population which strengthen the self help movement for their participation in developmental programmes. The self help movement also enable them to envisage their socio-economic status, self worth and dignity like have class people in the community. The distressed have not class of people are provided vocational training, income generating programme, skill development training, technical support and social support for their independent living in the community. 5. To adopt & implement Inclusive Education for Children with disabilities at secondary level for the complete educational rehabilitation of children with special needs.
6. To rehabilitate and trained up differently abled individuals, as well as to find ways to integrate them in to their communities.
7. To conduct different types of human resource development-training programmes such are teachers training programme on special education and other professional/ Personnel's courses for rehabilitation PwDs and community as a whole.
8. To create awareness among the citizens on health care, reproductive child health, family planning, Sanitation and provide health care & education and rehabilitation services on the issues of HIV, TB, Leprosy, Cancer and Hepatitis etc.

MAJOR ACTIVITIES
(2016-17)

1. Assistance to Disabled persons for purchase and fitting of aids & appliances.

As per right and equality (Act 1995 & UNCRPD) aids/appliances are basically needed for the primary rehabilitation of differently categories persons with disabilities and also enhance their socio economic status like normal persons in the community. Organization from its inception for a long span of time continued "ADIP" scheme with the financial assistance of Ministry of Social Justice & Empowerment, Govt. of India in 09 (Nine) districts of the state Odisha.

As per norm of the ADIP scheme, Organization liaising with district administration arranged distribution camps for the PwDs on 31/03/2017 at Neheru Stadium under Bhadrak District of the state Odisha. The program Inaugurated by the state commissioner for the persons with disabilities (SCPD) Dr. Minati Behera and also be conducted under the chairman ship of Prabhat Ku. Bhoi, the Additional District Magistrate (ADM), Bhadrak. It has been also be in presence of the district level dignitaries such are SJ. Laxminarayan Mishra, the Collector and District Magistrate (DM), Bhadrak, SJ. Sambit Mohanty DPC, SSA, Bhadrak and Raghunath Dhal, Chairman of Bhadrak Panchayat Samiti distributed/fitment of aids/appliances to different categories of PwDs.

Primary rehabilitation being the prime thrust of the scheme, it has been not only bring their physical mobility but also ameliorate their socio-economic status, self- confidence and individual autonomy of the PWDs in the community. During the year 2016-17, organization distributed/fitment 94 nos. of aids and appliances to 86 nos. of PwDs under Head-quarter and 30 nos. of aids and appliances to 28 nos. of beneficiaries under camp activities respectively at Bhadrak district of the state, Odisha.

As per requirement of the beneficiaries, organization also delivered post fitment care of aids/appliances to PwDs of Bhadrak and its adjacent districts i.e. Jajpur, Balasore & Keonjhar of the state Odisha.

2. Identification/ Assessment Camps for Persons with Disabilities.

The identification & assessment of PwDs traced out the magnitude problems of deformities for fitment of proper aids/appliances. Organization has been continuing the identification & assessment camp for persons with disabilities with the co-operation of local level NGOs, Panchayat sammittees, District administration, Lions clubs in 09 (nine) districts of Odisha i.e. Bhadrak, Balasore, Cuttack, Dhenkanal, Jajpur, Keonjhar, Kendrapada, Mayurbhanj and Nayagarh by a team of rehabilitation professionals. During the year 2016-17, **1486** nos. of persons with disabilities are identified for supply and fitment of aids & appliances in the above nine districts.

3. Clinical Services:

The Organization has been providing different clinical services such as X-ray, pathology, ECG etc. since last 16 years and during the current year, 8743 nos. of beneficiaries are benefited through free of cost/ nominal cost of services by which they are easily diagnosed for availing the health services. The Persons with disabilities and senior citizens from BPL families are availed the services in free of cost. The detail unit wise beneficiaries are covered are mentioned below:

5. Community Based Rehabilitation programme for the PwDs (CBR).

CBR is a community development program in the field of disability of prevention and rehabilitation. The strategy of Community Based Rehabilitation (CBR) activities is poverty alleviation programme which also be provided with the joint efforts of the persons with disabilities (PwDs). The parents of PwDs and community members. The wider objective of the programme is defined as a process where in knowledge about disability and skills in rehabilitation is transferred to the PwDs, their families and the members of the community effecting significant attitudinal changes and creating a more positive environment for over all holistic improvement in the life of Persons with disabilities.

Organization has been continuing the programme with the financial assistance of Dept. of Empowerment of Persons with Disabilities, Ministry of Social Justice & Empowerment, Govt. of India. During the year 2016-17, organization successfully implemented the program in 53 villages under 05 Nos. of Gram panchayats of Bonth block, Bhadrak district, Odisha. In each sub activity the voice of the PwDs dominated and they are also be involved in planning, implementation, monitoring and sustainability of the

programme. CBR strategy is a method where people at the centre. The mobile service delivery system reached in outreach remote rural project area to every PwD beneficiary for leading life with dignity and independently par with normal persons in community.

The rehabilitation professionals, CBR Workers in cooperation with PwDs, parents of PwDs and community members provided services in a non- institutional setting in an environment where services are seriously limited or totally absent within the limit of the project area. As per CBR strategy, activities are systematically initiated i.e. Door step survey, Social mobilization, Capacity building training programmes for PwDs and parents of PwDs and local leadership training program, home based education, vocational training, Formation of Self Help Groups (S.H.Gs) and linkages of PwDs with developmental schemes in the project area.

Community mobilization is the process of bringing together as many PwDs beneficiaries as possible to raise people's awareness and demand for a particular programme to assist in the delivery of resources and services and to strengthen community participation for sustainability and self reliance. A lot can be achieved when people from different parts of the community share a common goal and actively participate in both identifying needs and being part of the solution. As per the theme of CBR strategy organization formed 02 village level organizations and 06 nos. of CBR committees (one in each Gram Panchayat) in the project operational area. Each committee consisted with the PwDs, parents of PwDs, health worker "ASHA", PRI members, representative of local level NGOs and local level trained-up cadres. In each sub-activity, the presentation PwDs are given due emphasis on priority basis for coverage of mobile services to the indentified PwD beneficiaries. The theme of social mobilization activities to organize the people and organized people developed themselves.



To instill confidence, knowledge and skill in the field of disability, Organization arranged 05 nos. of capacity building training programme (One in each Gram Panchayat) for PwDs and parents of PwDs within the limit of the project area.

The panchayat level leaders, local cadres are also be provided capacity building training programmes for main streaming the various kinds of differently able with non differently abled and also to keep the continuity trend of activities within the limit of the project area.

The theme of the capacity building training program are cited below:

- ¥ The PwDs, Parents of PwDs and community members are sensitized and gained knowledge in health, education and skill to reduce the degree of deformities.
- ¥ To instil confidence of the PwDs.
- ¥ To be aware about different opportunities in public sector for their upliftment par with the normal persons in the community.
- ¥ To keep sustainable trend of activities within the limit of the project jurisdiction.

To enhance the skills for livelihood of the unemployed PwD youths, Organization provided mobile vocational training on coir-making, tailoring & handicraft, incense stick, phenol preparation and candle making in the operational area. All the ventures are technically viable and less expensive due to low technology by nature. The Products are easily marketable in the local markets and also be in the outside.

During the year 2016-17, organization trained-up 303 nos. of differently abled youths under different ventures of vocational training in the project area. The category wise PwDs and ventures are cited below.

As per the Article 28 of the “UNCRPD” the women with disabilities are provided social protection programmes and income generating programmes for their empowerment of independent living in the community.

The wider objectives of the Self Help Groups to bring the purchasing power of the (S.H.Gs) members for their employment and self employment in the community. So over the need based analysis of situations organization arranged 04 nos. of differently abled women Self Help Groups (S.H.Gs) and each group consisted with 07 to 10 members in the cluster approach villages of the project area.

The members of S.H.Gs accrued benefits cited below.

- Enhance their potency and initiate trust on themselves.
- Strengthen unity of team spirit & Co-operation.
- To incite their Co-operation and team spirit.
- The differently abled women S.H.G members detect their rights par with normal persons in the community.
- The members are aware about their entitlement of public resources in all aspects of life and leading independent living with dignity like others in society.
- The S.H.G members are habituated with the benefits banking transaction and also help the financial institutions by group decision in recovery and credit for prompt repayment of loan.
- The voice of S.H.Gs members honored in Pallisabha & Gramsabha where they have been participated in decision making process for the implementation of the developmental activities at grass root level.

As per the Act of “UNCRPD” there has been no discrimination between differently abled and normal children and all enjoy equal opportunities and fundamental freedom for their best interest in the community. The rehabilitation professionals and activities professionals delivered basic rehabilitation services and home based education to 145 nos. of children with disabilities within the age group of 0 to 15 years within the jurisdiction of the programmed area.

06. Special School for Spastic (CP & MR) Children.

As per the Article 24 of "UNERPD" it has been focused in the legislative frame work, the differently abled children enjoy human right and fundamental freedom on an equal basis like normal children. Spastic (CP & MR) children, being the vulnerable segment of population they are deprived of favorable environment, care protection and services and live on the sympathy of parents and community members. So over the precarious situations especially in the district, organization has been continuing Bhadrak Special School for Spastic (CP & MR) children with the financial assistance of Dept. of empowerment of persons with disabilities, Ministry of social justice & empowerment; Govt. of India.

The wider objectives of the institutional set up special school for spastic (CP & MR) students to bring better status of physical and mental state of thought, the residents are provided care, special services, Learning achievement and friendly environment which enhance their confidence and individual freedom and also bringing a change in such formative age like normal children. The passed out special students get admitted in Integrated/General schools. Organization deployed a part time physician who checked-up the health status of the residents from time to time. The activity professionals, rehabilitation professionals and vocational instructor provided basic rehabilitation services (i.e. early identification, primary intervention, secondary intervention, infant stimulation and therapeutical services), formal and non formal education, adapted physical education, ADL activities, behavioral modification, natural environment training, prevocational training etc. to the residents of the special school.

For the effectiveness of the special services, organization arranged 02 (Two) nos. of sensitization programmes for the parents of Spastic children in the premises of the special school. Parents gained

knowledge and skill in the field of disability and disseminated training inputs for their differently abled children.

Staff of the special school involved the differently abled students to participate in Local, National and International programmes i.e. Independence day, Republic day, International disabled day, Mental health day and district level sports competition among the residents of the special schools. The participation of the residents with different programmes incites their dormant spirit and also outlook par with normal children in all aspects of life.

07. MY HOME- A residential care centre for Autism, CP, MR & Multiple Disabled.

The National Trust disability areas i.e. Autism, C.P, M.R. & M.D Considered as the most distressed segment of population and not only deprived from the emotional bond of the family life but also spaced in the community, poverty alleviation programmes still not accessible to them and live on the sympathy of others. So over the precarious situations, organization started and continuing the “My HOME” centre under SAMARTH scheme since 1st March 2016 at Dahanigadia of Bhadrak district, state of Odisha.

The main objective of the Samarth scheme is to provide respite and residential care home for orphans or abandoned PwDs, families in crisis and PwDs from BPL & LIG families of the National Trust disability areas of all age group. Organization provided residential care and basic rehabilitation services to the National Trust disabilities PwDs (Autism, CP, MR & Multiple Disabled) in the centre for reducing the effect of disability and also bring a change in the mental state of thought within the institutional set up.



There are 30 (Thirty) nos. of residents those are belonged to BPL & LIG families enrolled in the centre. The deployed professionals/ staff i.e. physiotherapist, Medical Doctor, special educators, vocational instructor, Caregivers and Ayahs delivered services i.e. ADL activities, pre-vocational training, Vocational training, assessment and therapeutic management and behavioral management and recreational facilities within the institutional set up and also create favorable environment to ameliorate their existing status in the centre. The professionals also maintain the growth and development charts of the PwDs on regular basis.

Organization with the financial assistance of National Trust under Ministry of Social Justice & Empowerment, Govt. of India, started and continuing a permanent residential home namely "Ashraya Kutira" for the adult PwDs of National Trust disabilities area (Autism, CP, MR & Multiple Disabled) from 1st March 2016 at Charampa under Bhadrak district of state Odisha.



The main objective of Gharaunda Scheme is to provide an assured home and minimum quality of life of the persons with Autism, CP, MR & Multiple Disabled. The centre is an assured home where it has been created friendly environment and proper facilities of treatment for bringing the physical and mental state of thought of the residents. Concerned staff of the centre also maintains the growth & development chart of the resident on a regular basis.

The permanent residential centre has adequate equipment and facilities such as Medical & assessment room with therapeutical aids and appliances), vocational room, recreation room, hygienic lodging where the PwDs are easily accessible to the building due to barrier free. The concerned staff of the centre are deployed as per the norm of the scheme. There are 20 (Twenty) nos. BPL category of PwDs presently staying in the centre.

09. Physiotherapy clinic for Older Persons

In the existing scenario many thousands of senior citizens are still neglected by the society. The experiential wisdom of the aged is not being considered productive in this age of mass technological production. More over the concept of the retirement from work is leading to lowering their status as non productivity entity. In old aged the biological system of body is weekend and they are being prone to various diseases at that time they are absolutely needed physiotherapy treatment for bringing back their health status to normal position. Therefore, the present and expected increase in the ratio of the senior citizens in the future calls for greater attention to the financial, physical, sociological and psychological response to the problems that are specific to the elderly.

In the backdrop of the above lines situations during the year 2016-17, organization has been delivered physiotherapy services to 613 nos. of senior citizens at Dahanigadia, Charampa under Bhadrak district of the state Odisha.

Organization has sound infrastructure well equipped with Laser therapy, Short wave Diathermy (SWD), Interferential therapy, Muscle stimulator, Ultrasound Therapy, Computerized cervical thoracic and lumber traction, Therapeutic bed, Hydroculator, Shoulder exerciser, Wrist exerciser, multi exerciser gym, Continuous Passive machine (CPM), static cycle, foot management machine, staircase and Para wax bath etc. Organization deployed experienced physiotherapist to deliver services to the senior citizens. In the physiotherapy clinic it has been created friendly environment and sound service delivery system to meet the sensitive and emotional needs of the senior citizens.

10. Aspiration- A Day Care Centre for Autism, CP, MR & Multiple Disabled Children

The differently abled children are also be legally entitled to ensure full enjoyment of human rights and fundamental freedom on an equal basis of normal children in the community. The distressed children of the National Trust disability areas (Autism, CP, MR & Multiple disabled) provided care, services and emotional bond for those who are spaced in the community. So over the plight of the differently abled children under National Trust disabilities areas organization continuing the day care centre since 2nd January 2006 at Magurgadia under Sadar block of Keonjhar district, Odisha.



The wider objectives of the schematic programme, the rehabilitation and activity professionals ensure special education, services and friendly environment which enable them to get admitted in integrated and special schools suiting to their deformities. The part time physician also check-up the health status of the residents on regular basis. Professionals provided special education i.e. formal and non formal education, adopted physical education; skill of basic management, skill of daily living activity, behavioral modification, therapeutic management and pre-vocational & vocational training to the residents. Presently there are 30nos. of children enrolled in the centre.

11. Low Vision Centre:

Low vision is a serious health problem and presently it has been urgently needed to implement comprehensive prevention programme to combat the existing rising trend of this segment of population in the community. Out of our experience we feel there are many causes of low vision including infection, malnutrition, injury and aging. Majority poor people are with low vision are living in the remote rural areas where prevention and treatment efforts are extremely difficult over the plight of persons with Low vision; Organization set up the low vision centre where service delivery system has been continuing since 1st April 2003 in Bhadrak district state of the state, Odisha.

The wider Objectives of the Low vision centre to assist a person with Low vision; deliver services i.e. identification, assessment, prescribed appropriate optical aids and mobility training which will improve the visual efficiencies and social activities par with normal persons in the community.

The two most common causes of low vision are cataract and trachoma each accounting for over 1/3 of cases, Cataract mainly a disease of older people; the lense of eye becomes opaque. Trachoma mainly caused by an infection and other reasons. The persons with low vision below poverty line are also availed the opportunities of surgery of cataract and trachoma in free of cost.

Our ophthalmologist properly diagnosed and prescribed magnifying glasses and in case of any complicity arises referred for treatment to district Head Quarter Hospital and state level hospital. Besides medico rehabilitative services the ophthalmologist also be imparted health literacy and advised special services to enhance the visual efficiency of persons with low vision. During the year 2016-17, there are 3037 nos. persons with low vision delivered services from Bhadrak, Balasore, Jajpur and Keonjhar districts of the state of Odisha. Children with low vision below 15(fifteen) years being considered as the formative age, organization provided orientation & mobility training to improve their visual efficiency to the maximum extent of possible.

12. SAHYOGI- Advance Caregiver training Programme:

CRSR has been successfully completed the Six months Advance caregiver training programme under SAHYOGI scheme of the National Trust during the period 27/07/2016 to 26/01/2017 including 03 months theory class and another 03 months of internship. The training programme was inaugurated by the Collector & District Magistrate, Bhadrak Sj. Laxminarayan Mishra. The batch consisted with 30 (Thirty) nos. of trainees where 29 nos. of Caregivers are trained up.

The theme of Advance caregiver training programme is to trained the candidate in advanced caregiver skills and create a skilled workforce to support high need persons with Autism, Cerebral Palsy, Mental Retardation and Multiple Disabilities, their families and institutions (Hospitals, schools etc.). During the internship period, Caregivers delivered services to the selected Careseekers of National Trust disabilities areas (Autism, CP, MR & Multiple Disabled) at their homes. The training programme conducted in lecturing cum participatory process and emphasis also be given on practical classes due to its importance for dissemination of services to the care seekers. The caregivers being aware about legislative frame work and different opportunities in public sector, they also assist distressed care seekers and other PwDs to rehabilitate them in community.

13. Observance of World Mental Health Day:

World mental health day is observed on 10th October of every year, with the overall objective of raising awareness of mental health issues around the world and mobilizing efforts in support of mental health. The world is going through a crisis. There are many disasters, wars and migration growing problems and many people require basic psychological and mental aid and first aid to prevent their health from deteriorating and to empower them to take action to improve their mental health.

The objectives of the mental health day is that to provide basic psychological and mental health and first aid services so that they are able to support the distressed individuals in the same way as they do in physical health arises. Now the attitude towards mental illness has been completely changed and it is realized that no stigma should be attached to such illness as it is curable particularly when diagnosed at an early stage.

For raising awareness about the modified mental health Act 1987, organization in collaboration with district legal aid Services Authority (DLSA) Bhadrak, celebrated the World Mental Health Day on 10.10.2016 at the conference hall of the organization, Charampa, Bhadrak of the state Odisha. The occasion conducted under the chairmanship of Sj. Debasis Parida, Secretary of DLSA , Bhadrak, As guests of honor, Smt. Lalita Manjari Pattnaik, registrar of civil court, Sj. There are 250 PwDs, parents of PwDs, representatives of local NGOs and social workers participated in the occasion. At last Promod Kumar Nayak, Project coordinator of the organization, gave thanks to the PwDs, parents of PwDs and invited guests and called off the programme.



14. Vocational Training Centre for PwD Youths.

Over the self employment and employment situations of the differently abled youth in Bhadrak district, there has been a dire need of vocational training centre in Bhadrak district. In the context of the precarious circumstances, organization started the viable paramedical vocational training programme on 1st April 2002 by its own contribution and till continuing on. Our experienced personnel imparted training programme in theory with emphasis of practical classes. Each batch consisted with 30 nos. of orthopedically and hearing differently abled trainees. During the year 2016-17, out of total enrolled 02 batches 60 (Sixty) nos. of trainees, there are 50 (fifty) nos. of differently abled youths (orthopedically and hearing impaired) successfully completed the training programme.

At the outset of the work-shop, there has been an arrangement of district level Marathon race of senior and junior groups among the differently abled competitors of The National Trust disability areas. The superintendent Police (SP) Bhadrak flagged off to start the marathon race a distance of 1 KM from collectorate to Karmachari Bhawan, Bhadrak.

Sj. Dillip Das, S.P of Bhadrak; inaugurated the work-shop. The workshop conducted under the chairmanship of Sj. Sibaram Dhal, DSSO, Bhadrak. The guests of honor Sj. Manoj Kumar Das, District Sports Officer, Sj. Jaladhar Mandal, the IED coordinator of SSA, Bhadrak, Dr. Bhagaban Parida, the chief



functionary of CRSR, Bhadrak and Sj. Akshaya Kumar Sahoo, Secretary of Odisha Vikalanga Mancha, Participated in the workshop.

Sj. Das, SP of Bhadrak district; gave his opinion that it has been imperatively needed the support of public and private sectors to rehabilitate this vulnerable segment of population in the society. 16. District level Mega Bhimabhoi Bhinnakhyam Samarthya Shibira for the PwDs:

Bhimabhoi Bhinnakhyam Samarthya Shibira is a programme of Govt. of Odisha, Department of SSEPD in which Organization has actively participated with District Administration (District Social Security Section) and Sarba Sikshya Aviyan (SSA), Bhadrak to implement the programme in Bhadrak district, Odisha. It was held on 31.03.2017 at the Nehru stadium of Bhadrak where 1289 nos. of PwDs of different categories registered their names. The programme was inaugurated by the state commissioner for the persons with disabilities (SCPD) Dr. Minati Behera and also be conducted under the chairmanship of Sj. Pravat Ku Bhoi, the additional collector, Bhadrak. The guests of honor i.e. Sj.Laxminarayan Mishra, the district magistrate and collector, Sj. Narottam Behera, the sub-collector, Bhadrak, Sj. Radhakanta Mohanty, the representative of the M.L.A of Bhadrak constituency, Sj. Raghunath Dhal, Chairman of Bhadrak Panchayat Sammiti; Sj. Saroj Kumar Nayak, member of Bhadrak Zilla Parisad; Sj. Manas Kumar Mohanty, Chairman of Bhadrak Municipality; Mrs. Jyostnarani Rout, Vice Chair Person of Bhadrak Panchayat Samiti; Mrs. Ashalata Mohanty, DSWO; Sj. The main aim of the programme was to provide several facilities to PWDs at one place in a single day, through single window camps because of a persons with disability has to run several times to many offices from pillar to post to get even basic facilities like disability certificate, aids/appliances, fare concession passes, information on relaxations and concessions, Health Insurance, which is Herculean task involving harassment, physical & mental stress, loss of wages etc. Out of 1289 nos. of Registered PWDs, 782 nos. deserved PWDs provided proof of documents from 20 (twenty) nos. of counters i.e. registration, health insurance centre, assessment of disability registration centre and employment training centre etc. In the camp, 736 nos. Mental Retardation (M.R) and Cerebral Palsy (C.P) and 553 nos. of hearing impaired properly assessed and reregistered. There were 132 nos. of PWDs distributed artificial limbs and calipers distributed/fitted to the PWDs, mission Kshyamata to 08 nos. of couples (one differently abled non differently abled).

To sensitize the parents and school Teachers about National trust disability areas (Autism, Cerebral Palsy, Mental Retardation & Multiple Disabilities) Children & People , Organization has conducted an awareness programme at it's conference hall, Charampa, Bhadrak on dated: 05.11.2016. The programme was inaugurated by the Collector & District Magistrate, Bhadrak Sj. Laxminarayan Mishra, IAS and presided by the District Social Security Officer, Bhadrak Sj. Sibaram Dhal. In the awareness programme, it was vividly discussed about the types of disability under National Trust Act, its causes, identification, its prevention and rehabilitation, Therapy management, Assistive devices to enhance their mobility, ADL training, PWD Act, Govt. facilities and various schemes and residential care homes run by the organization for Autism, CP, MR & Multiple Disabled children.



20. Therapeutic and rehabilitative Services for the persons with Intellectual Disabilities

CRSR, with the financial assistance of Dept. of social security & Empowerment of persons with disabilities (SSEPD), Govt. of Odisha, has started the therapeutic and rehabilitative services for the PwDs on 1st April 2016 at the working office Dahanigadia; Charampa; Bhadrak, state of Odisha.

The major objective of the centre is to provide identification, assessment, rehabilitative counseling and referral services, and assist children with intellectual disabilities to reach their maximum potential through respite care, pre-vocational, Vocational training and therapeutic services.



The centre is well equipped with individual bed for each inmates, medical room or assessment room with therapeutic & aids/appliances, one activity room or vocational room and one recreation room.

Organization providing group home facilities for all age groups of Persons with Cerebral Palsy, Mentally retarded, Autism and Mentally illness with adequate and quality care services with acceptable living Standard. A range of services provided in the centre i.e. Residential Care (Respite home), pre-Vocational & vocational Training , Physiotherapy & Occupational services, Medical services through

Clinical Psychologist, Psychiatrist, behavioural specialist, speech therapist and Physicians, Informal education and training in the form of pre-school intervention, Personal care and daily living skills. Our Rehabilitation professional as per individual case study cum assessment chart, delivered special education and ADL activities systematically.

During the year 2016-17, there are 30 nos. of beneficiaries with intellectual disabilities delivered services in the centre.

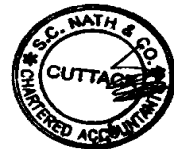


